Generation of Statistics for the Compendium of Humanitarian Indicators for Kenya

Terms of Reference

1. Background

Humanitarian crisis across the globe continue to increase in frequency, complexity and size, challenging the ability of nations and organizations in disaster relief to prevent, respond and build resilience. Most of the crisis are complex emergencies, bearing elements of conflict and disasters that, more often than not, cause mass displacements, mortality and massive property loss and damage. Disasters in Kenya can be categorized into five, namely hydro-meteorological, geological, biological, technological and environmental. Hazards are characterized as slow and rapid onset hazards.

Kenya is making progressive strides towards strengthening disaster risk management laws, policies and strategies for effective prevention, preparedness, mitigation, response and recovery. The Country has endorsed and continues to develop the necessary policy and legal infrastructure for implementation and reporting on global compacts on disaster risk management such as the Sendai Framework for Disaster Risk Reduction (2015-2030) and Sustainable Development Goals (Goal 16), and the Paris Agreement (2015) as a signatory to the United Nations Framework on Climate Change. Kenya supports the Africa Regional Strategy for Disaster Risk Reduction and the IGAD's Disaster Risk Management programme which dovetail into the Africa Agenda 2063. Kenya has been a global champion of the ICPD Programme of Action that led to renewed commitments, including on humanitarian action, during the ICPD25 Nairobi Summit in 2019.

The growing prioritization of disaster risk management in Kenya lacks systematic and robust systems and structures for comprehensive evidence generation to inform policy and strategic actions. The census, survey and administrative data sources that exist do not comprehensively highlight disaster management as a critical area for documentation and dissemination. The data available through census and surveys is periodic and therefore not extremely reliable for emergencies that remain largely unpredictable. Administrative data like DHIS is restricted to indicators that do not cover the entire spectrum of emergencies in the country. Even with the existence of various sources of data across key sectors, including agriculture, education, health, nutrition, WASH, food security and livelihoods and social protection, Kenya does not have a centralized system for making data available during emergencies. Data on population issues such as SRH and protection risks is yet to be fully mainstreamed into DRR for holistic programming which leads to marginalization of population related concerns in DRM programmes in the country. Inadequate availability of humanitarian data in Kenya is an impediment to effective costing and forecasting of the economic implications of emergencies in the country. To address these gaps, the National Council for Population and Development (NCPD in collaboration with UNFPA and other stakeholders are in the process of developing a humanitarian database.

2. Rationale of Humanitarian Database

There is a growing recognition of the critical role that information management can play in shaping effective humanitarian response, coordination and decision-making. Quality information, reaching more humanitarian actors, will result in better coordination and better decision-making, thus improving the response to beneficiaries as well as accountability to the Government and donors. The humanitarian database will encompass country-level data-and-trend analysis about humanitarian crises and assistance. Its purpose is to consolidate this information and present it in an accessible way, providing policymakers, researchers and humanitarian practitioners with an evidence base to support humanitarian policy decisions and provide context for operational decisions. Development and utilization of the database will contribute to effective and efficient planning and response to emergencies, ensuring better precision in targeting and deployment of resources to minimize wastage and exclusion of critical needs. The database will support integration of DRR into multiple sectors and inbuilt actions across the humanitarian, development and peace nexus.

The National Council for Population and Development (NCPD) is a semi-autonomous Government agency charged with the responsibility of coordinating the implementation of Kenya's population policies and programmes. The Council, with support from UNFPA, seeks to engage the services of a consultant who will generate statistics for the compendium of humanitarian indicators for Kenya's humanitarian database.

3. Objectives of the Consultancy

The main objectives of the consultancy for the generation of statistics for the compendium of humanitarian indicators for Kenya's humanitarian database are:

- a. Assess the comprehensiveness of the compendium of humanitarian indicators identified for Kenya's humanitarian database
- b. Identify and include in the compendium of indicators for Kenya's humanitarian database any other indicators that may have been omitted
- c. Generate statistics for each of the indicators in the compendium at various levels i.e. National, County and sub-County levels
- d. Propose a suitable way for presenting the generated statistics in the humanitarian database

4. Scope of Work

The consultant will undertake the following activities to achieve the objectives stated above:

- a. Review and update missing indicators and datasets in the 'Report on the Compendium of Indicators for Kenya Humanitarian Database on Population and Development'
- b. Generate statistics for each of the indicators in the compendium at various levels i.e. National, County and sub-County levels
- c. Document the methodology used to generate the statistics on the humanitarian indicators for Kenya's humanitarian database.
- d. Provide recommendations on how and when the statistics in the humanitarian database should be updated
- e. Support the consultant who will develop the online humanitarian database on population and development to determine issues of data presentation among others.

5. Key Deliverables

The expected deliverables for the assignment are:

- a. Statistics for each of the indicators in the compendium of indicators for the country's humanitarian database
- b. Report on the methodology used to generate the statistics on the indicators for Kenya's humanitarian database.
- c. Recommendations on the updating of the statistics in the humanitarian database

6. Assignment Duration

The consultant contracted to undertake the generation of statistics for the compendium of indicators for the humanitarian database is expected to complete the assignment within 30 days from the date of signing the contract.

7. Qualifications of the Consultant

The consultant who will be contracted to undertake the assignment described above should demonstrate the following professional credentials, skill sets, competences and experience;

- a. A Master's degree in Population Studies, Demography, Statistics, Economics or other relevant discipline.
- b. Experience in humanitarian and development programme design, implementation and management.
- c. Experience in conducting similar or related consultancy work.
- d. Knowledge of national legislations and policies of the Government of Kenya relating to disaster risk management.

- e. Experience in providing technical assistance to Governments, UN bodies and NGOs in the area of data generation and utilization.
- f. Familiarity with census, survey and administrative data collection and management processes in Kenya (Census, DHS, DHIS, vital statistics, etc).

8. Expression of Interest

Applicants interested in this position should submit the following documents:

- a. A detailed technical proposal that demonstrates understanding of the task, proposed methodology and timelines.
- b. A financial proposal in Kenya Shillings and the preferred payment schedule.
- c. Samples of relevant work done in the past and at least two references to vouch for the consultancy applicant.
- d. A cover letter that demonstrates suitability for undertaking the assignment.
- e. CVs of the consultant(s) to undertake the task.

9. Consultancy Management

The consultant will report to the Director General of the NCPD for overall oversight while receiving technical and routine support from the technical team at NCPD.

Introduction

Humanitarian situations in Kenya normally arise from disasters and emergencies that result from hazards such as drought, floods, landslides, civil conflicts, and accidents among others. When these situations arise, they lead to the destruction of property, loss of life and livelihoods, injuries, and diseases. Disasters and emergencies are known to disrupt the normal functioning of a community thereby affecting the provision of basic and essential services such as healthcare, education, water, housing, and access to food. Oftentimes, the resources in affected communities are inadequate to effectively respond to disasters and emergencies thereby necessitating external assistance from other communities, disaster response organizations, specialized government agencies, specialized United Nations agencies, and non-governmental organizations. The best practice in Humanitarian affairs calls for multi-agency approach interventions across all phases of a disaster and emergency.

Humanitarian data is valuable before, during, and after interventions in order to increase the efficiency and effectiveness of humanitarian efforts. This allows humanitarian actors to identify those in need and deliver well targeted aid, where necessary. Humanitarian needs have continued to be made complex by the increased frequency, magnitude, and severity of disasters. However, the availability of data on affected populations facilitates the development and implementation of targeted actions that effectively respond to the needs of affected communities. Unfortunately, most times when disasters and emergencies occur, population data is usually not readily available for use by the responders. This is compounded by the fact that Kenya lacks a centralized humanitarian database which would effectively eliminate duplication of duties and enhance the proper placement of resources in humanitarian assistance as well as focus on priority areas.

Having identified the absence of a centralized humanitarian database in Kenya, the National Council for Population and Development (NCPD), with financial and technical support from UNFPA, brought together some stakeholders in the humanitarian sector to develop a centralized online database. This report therefore presents the compendium of indicators for the humanitarian database that were agreed on by the stakeholders. The report also shows the sources of data for computation of the indicators as well as the stages of disasters and emergency at which the data is required.

Objectives of the Compendium of Indicators

The main objective of the development of a compendium of indicators for the humanitarian database on population and development is to facilitate the strengthening of disaster and emergency risk systems, policies and strategies for effective mitigation/prevention, preparedness, response and recovery in Kenya. The specific objectives of the development of the compendium of indicators are;

- i. To facilitate a centralized system for making data available for use during disasters/emergencies at national and county level
- ii. To improve on effective costing and forecasting of the economic implications of emergencies at national and county level
- iii. To improve on effective and efficient planning and response to disasters for reducing both the human, social, economic and financial costs whenever they happen
- iv. To enhance accountability and response to disasters by MCDAs and humanitarian organizations working in the country.

Methodology

Various methodology techniques were applied to develop the compendium of indicators in Kenya. A small technical team comprising of NCPD, NDMA and NDMU was appointed to undertake the task. The team started by undertaking a comprehensive literature review on relevant documents to establish pertinent data needs for the humanitarian context. The team was divided into groups where each looked at various indicators and data sources. In a group plenary, a review was undertaken on the existing indicators relevant to the humanitarian context that came from the groups after which appropriate indicators for the compendium of humanitarian indicators were selected. The indicators were mapped, consolidated and the data sources for each indicator established. The indicators were then aligned in phases of humanitarian action continuum that are in four categories namely; Mitigation/prevention, Preparedness, Response and Recovery.

Kenya Compendium of Indicators for Humanitarian Database

The compendium of indicators for Kenya's proposed humanitarian database will be used to describe and measure different aspects of humanitarian aid. Its purpose is to provide consolidated information on humanitarian indicators and present it in an accessible way thereby providing policymakers, researchers and humanitarian practitioners with an evidence base to support humanitarian policy decisions and provide context for operational decisions. Table 1 shows the agreed Kenya Compendium of Indicators for the proposed humanitarian database;

3. NCPD hereby covenants to pay the Supplier/Contractor/service provider (*select one*) in consideration of the provision of the Goods/works/services (*select one*) and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.

CONDITIONS OF CONTRACT

1. Language

The Contract as well as all correspondence and documents relating to the Contract exchanged by the Supplier/Contractor/Service Provider (*select one*) Provider and NCPD, shall be written in the English Language.

2. Eligibility

The goods shall have the nationality of an eligible country. All Goods and Related Services to be supplied under the Contract shall have their origin in Eligible Countries.

3. Notices

Any notice given by one party to the other pursuant to the Contract shall be in writing.

4. Governing Law

The Contract shall be governed by and interpreted in accordance with the Laws of Kenya, unless otherwise specified hereunder.

5. Settlement of Disputes

NCPD and the Supplier/Contractor/Service (*select one*) shall make every effort to resolve amicably by direct informal negotiation any disagreement or dispute arising between them under or in connection with the Contract. If the parties have failed to resolve their dispute or difference by such mutual consultation, either NCPD or the Supplier/Contractor/Service (*select one*) may give notice to the other party of its intention to commence arbitration. The dispute shall be referred to adjudication or arbitration in accordance with the laws of Kenya.

6. Supplier/Contractor/Service Provider Responsibilities

The Supplier/Contractor/Service Provider (*select one*) shall supply all the Goods included in the Schedule of Requirements.

7. Contract Price

Prices charged by the Supplier/Contractor/Service Provider (*select one*) under the Contract shall not vary from the prices quoted by the Supplier/Contractor/Service Provider (*select one*) in its quotation.

8. Terms of Payment

The Contract Price shall be paid One hundred (100) percent of the Contract Price as follows (*select one*):

i) For Goods, price of goods received upon submission of a claim/invoice supported by the acceptance certificate issued by NCPD.

(ii) For Works, upon valuation by the Contractor of the portion of the works completed, such valuation to be accepted by NCPD, payments up to final completion certificate.

(iii) For Services, upon valuation by the Service Provider of the services completed, such valuation to be accepted by NCPD, payments up to final completion certificate

9. Inspections and Tests

The Supplier/Contractor/Service Provider (*select one*) shall at its own expense and at no cost to NCPD carry out all such tests and/or inspections of the Goods, works or Services to confirm their conformity to technical specifications.

10. Warranty

The Supplier warrants that all the Goods are new, unused, and of the most recent or current models, and that they incorporate all recent improvements in design and materials, unless provided otherwise in the contract.
